

- O2 Dashboards Connect Hub provides the connectivity to the Pensions Dashboard Programme's Central Digital Architecture (CDA) and accepts and validates 'finding' requests before routing them to Dashboards Connect Match.
- O3 Bravura automates the matching, combines responses, sends and tracks timing of all activities.
- 04 We then register the pension identifier to the dashboard and the CDA to capture all the data required by the PDP for reporting purposes, storing only unique keys.
